## **SMALL WIRELESS FACILITIES APPLICATION SUBMITTAL NOTICE**

### **PURPOSE:**

This notice is prepared in accordance with the Council Policy on Small Wireless Facility and Other Infrastructure Deployments Within the Public Right-of-Way, adopted by City Council Resolution No. 2019-87, and posted on the City website and emailed to individuals and entities pre-registered in the Small Cell Notice Registry, to inform the public of the application filing listed below.

### **Project Descriptions:**

Verizon Wireless is requesting an approval to install and operate a new small wireless facility within the public right-of-way of the 2200 block of San Ramon Valley Blvd. The proposed wireless facility consists of an of three antennas near the top of a 30-ft. tall pole with associated equipment boxes at a minimum of 8-ft. above grade.

### **Action:**

The Community Development Director intends to act on the Small Cell Site License (SWSL 2022-0018) application with no formal hearing on Monday July 18, 2022. The Director's decision may be objected by interested residents within 300 ft. radius of the project location by 5:00 p.m. on Friday, July 22, 2022. An objection shall be filed with the Planning Services Division, and the City Manager will review the entire record pertaining to the application and issue a final decision within 10 days of the Application Decision Notice issuance.

All public comments in response to this notice shall be directed to the Planning Services Division listed below. If you challenge this application in court, you may be limited to raising only those issues you or someone else raised in written correspondence prior to the Community Development director action.

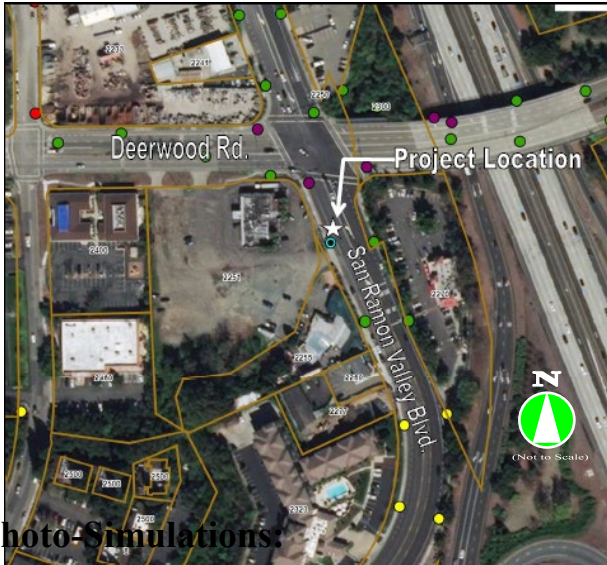
