

NOTICE OF AVAILABILITY OF THE SAN RAMON GENERAL PLAN 2040 DRAFT ENVIRONMENTAL IMPACT REPORT (DEIR) (SCH # 2022060549) AND NOTICE OF A PLANNING COMMISSION PUBLIC HEARING ON TUESDAY, SEPTEMBER 19, 2023 AT 6:00 PM IN THE CITY HALL COUNCIL CHAMBERS TO SOLICIT COMMENTS ON THE DRAFT EIR AND PROJECT

NOTICE IS HEREBY GIVEN that, the City of San Ramon (City), as the lead agency under the California Environmental Quality Act (CEQA), has prepared a programmatic Environmental Impact Report (EIR) for the San Ramon 2040 General Plan. The Draft EIR is now available for public review and comment.

This General Plan Update constitutes an amendment of the General Plan and, pursuant to Government Code §65352, referral of the proposed action for a 45-day review and comment period is provided.

Applications: A City-initiated General Plan Amendment (GPA 2023-0002) to update the General Plan and

Climate Action Plan (CAP) to guide growth and development through 2040. The Project also includes associated Rezone (RZ 2023-0002); Prezone (PZ 2023-0001); Specific Plan Amendment (SP 2023-0001); and Environmental Review (ENVR 2023-0003) applications.

Project Description:

The San Ramon General Plan 2040 is a long-range plan that guides decision-making and establishes rules and standards for new development and City improvements. It reflects the community's vision for the future and is intended to provide direction through the year 2040. State law requires the City to adopt a comprehensive, long-term General Plan for the physical development of its planning area. The San Ramon General Plan 2040 Update includes the updates to State-mandated elements and discretionary elements:

(1) Economic Development, (2) Growth Management, (3) Land Use, (4) Traffic and Circulation, (5) Parks and Recreation, (6) Public Facilities and Utilities, (7) Open Space and Conservation, (8) Safety, (9) Noise, (10) Air Quality and Greenhouse Gas. The Project also includes an update to the Climate Action Plan (under separate review), amendments to the San Ramon Village Specific Plan, repeal of the North Camino Ramon Specific Plan, associated Municipal Code Zoning Ordinance amendments, and Zoning

Map changes that will implement the General Plan.
